SMOKING & TOBACCO POLICY

The Town of Derby has established this policy to protect workers by prohibiting smoking and use of smokeless tobacco in the workplace except in designated areas.

The United States Surgeon General, in his 1986 report on Involuntary Smoking, Concluded:

- Involuntary Smoking is a cause of disease, including lung cancer; in healthy nonsmokers:
- The simple separation of smokers and nonsmokers within the same air space may reduce, but does not eliminate, the exposure of nonsmokers to environmental tobacco smoke.

The Town of Derby has adopted the following policy. Smoking and use of smokeless tobacco products is strictly prohibited within all Town of Derby owned buildings including offices, hallways, reception area, restrooms, lunch rooms, kitchens, garages, meeting rooms, and all other work areas. Smoking and use of smokeless tobacco products is strictly prohibited within all Town of Derby owned vehicles.

This policy applies to all employees, clients, contractors, and visitors. Smoking may only occur at a reasonable distance outside any enclosed area where smoking is prohibited to insure that environmental tobacco smoke does not enter the area through entrances, windows, ventilation systems or any other means.
