Pursuant to the provisions of Title 19, §709, Vermont Statutes Annotated, notice is hereby given that the Selectboard of the Town of Derby, Vermont, will meet at the Derby Municipal Build, 124 Main Street, Derby Center, Vermont, a public place in said town, at 6:00 o'clock in the afternoon on December 9, 2024, for the purpose of receiving testimony and hearing all persons interested in the matter of whether the following described road in said town should be discontinued as a Town Highway, to wit:

It being a 0.90-mile portion of Town Highway Number 37 (Robillard Road). Said portion of Town Highway is designated on the Derby Town Highway Map as a Class 3 road 0.15 mile and a Class 4 road 0.75 mile, the centerline of which is described as follows: Commencing at the intersection of the centerline of Town Highway Number 38 (Bates Hill Road) and Town Highway Number 37 (Robillard Drive), thence proceeding in an westerly direction to the intersection of Legal Trail Number 4.

It being Town Highway Number 55 (Willard Drive) in its entirety. Said Town Highway is designated on the Derby Town Highway Map as a Class 3 road, the centerline of which is described as follows: Commencing at the centerline of the intersection of Town Highway Number 54 (Bushey Hill Road) and Town Highway Number 55 (Willard Drive), thence proceeding in a southeasterly direction to the end.

It being a 0.05-mile portion of Town Highway Number 62 (Greenwood Lane). Said portion of Town Highway is designated on the Derby Town Highway Map as a Class 3 road, the centerline of which is described as follows: Commencing at the intersection of the centerline of Town Highway Number 58 (Missionary Acres) and Town Highway Number 62 (Greenwood Drive) which is 0.08 miles from the intersection of the centerline of Town Highway Number 4 (Darling Hill Road), thence proceeding in an easterly direction to the end.

It being Town Highway Number 65 (Batchelder Drive) in its entirety. Said Town Highway is designated on the Derby Town Highway Map as a Class 3 road, the centerline of which is described as follows: Commencing at the centerline of the intersection of Town Highway Number 38 (Bates Hill Road) and Town Highway Number 65 (Batchelder Drive), thence proceeding in a northerly direction to the end.

It being Town Highway Number 70 (Ledgewood Drive) in its entirety. Said Town Highway is designated on the Derby Town Highway Map as a Class 3 road, the centerline of which is described as follows: Commencing at the centerline of the intersection of Town Highway Number 58 (Missionary Acres) and Town Highway Number 62 (Ledgewood Drive), thence proceeding in a westerly direction to the end.

The proceedings have been initiated by the Selectboard pursuant to the provisions of Title 19, §708(a) of the Vermont Statutes Annotated. If after examination of the premises and hearing any and all interested persons, the Selectboard judges that the public good, necessity and convenience of the inhabitants of the Town of Derby requires that said legal trail be so discontinued, it will be so ordered.
